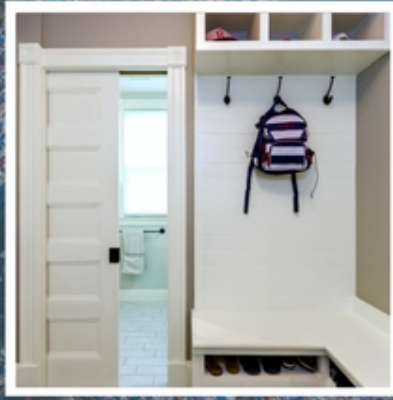

TRIPLE PLAY REBATE OFFICIAL RULES & REGULATIONS

Effective January 1, 2018, these official rules govern the Triple Play Rebate Program. Fairview Millwork, Inc. reserves the right to make changes to these official rules at any time. Please check www.fairvu.com to ensure you are aware of any updates or changes. Your participation in the Triple Play Rebate indicates acceptance of these official rules.

1. OFFER PERIOD: January 1, 2018 – December 31, 2018

Products must be purchased and fully paid for between January 1, 2018 and December 31, 2018 to qualify.

2. ELIGIBILITY: Eligible participants are customers, legal residents of the United States, 18 years and older. Employees (and members of their household and immediate family; i.e. spouse, parents, children) of sponsor are ineligible to participate in this program.

3. QUALIFYING PURCHASES: In order to qualify for a rebate, eligible participants must purchase products from all of the three phases (Exterior, Interior, Kitchens) as stated below and all purchases must be used for the same building project.

- a. Exterior Phase: Participants must purchase a minimum of \$2,500 in exterior millwork, which includes, but not limited to windows, exterior doors, skylights, trim, columns, garage doors and transoms, and decorative glass.
- b. Interior Phase: Participants must purchase a minimum of \$2,500 in interior millwork, which includes, but not limited to, interior doors, mouldings, flooring, stair parts, and hardware.
- c. Kitchen Phase: Participants must purchase a minimum of \$2,500 in kitchens including cabinets, countertops, sinks, faucets, and hardware.

All qualifying purchases must be paid in full with no outstanding balance due in order for a purchase to be deemed “qualifying.” This offer may not be combined with any other Fairview promotions.

4. REBATE VALUE

The rebate value is calculated as 3% of the total qualifying purchases (minus returns, credits, sales tax, shipping, and/or mark ups) for all three phases as stated above.

5. HOW TO SUBMIT REBATE CLAIMS:

Eligible customers (individuals or companies) must submit all of the following:

- a. A legible, fully completed **Rebate Form**.
- b. **Copy of original sales receipts** from each phase of the project.
- c. **A W-9** (Request for tax payer ID number & certification) will be required prior to the issuing of any rebate check.

6. REBATE CLAIM FILING DEADLINE:

Eligible rebate claims must be postmarked by or received at Fairview Millwork within 90 Days of the final invoice date.

7. REBATE PAYMENT

Payment of approved rebate claims will be mailed within 3-4 weeks after receipt of claim. All rebate claims will be paid by check, in US dollars and mailed via regular first class mail.

8. OTHER TERMS AND CONDITIONS

When required by the IRS, a 1099 may be issued to all customers that are not registered as a company or a corporation for rebates greater than \$600.00 per calendar year and when product was initially paid for by a 3rd party. This offer is void where prohibited or restricted by law. Misuse of this rebate request constitutes fraud.
